## **Discussion Notes:**

Augustin welcomed CLC members and shared a Land Acknowledgment, offering gratitude to First Nations, Métis, and Inuit for allowing us to be stewards of the land on which BWXT operates. Augustin shared the agenda, followed by a safety moment and reviewed the open and ongoing action items.

Augustin provided CLC members with an update on BWXT's Indigenous Relations Roadmap, highlighting the document is an internal guide for leadership to align business efforts in support of Indigenous Truth and Reconciliation, and to lay the foundation for future Indigenous Relations work. Augustin shared that the roadmap is available on [nec.bwxt.com](http://nec.bwxt.com) and encouraged CLC members to review the document.

Augustin shared that BWXT will be conducting its community surveying in October and outlined that this occurs every two years. One of the questions added this year was about primary language in the household, as CLC members had wanted to better understand why BWXT translates its community newsletters to Portuguese.

Augustin then informed CLC members that BWXT would be hosting a community event on November 26 from 4:00-7:00 p.m. in the facility parking lot. She encouraged CLC members to attend and shared that CNSC has been invited to participate. CNSC representative Amalraj noted that CNSC would not be able to attend this event. Augustin shared that BWXT would be advertising for the event using a multi-pronged approach. She then added that we invited Western Technical Commercial School's FIRST Robotics team to provide a demonstration of their robot.

Augustin next shared that BWXT is actively recruiting new CLC members and noted that the recruitment campaign would be underway shortly.

Augustin provided some community relations updates:

- BWXT hosted a visit and facility tour to the Mississaugas of the Credit First Nation.
- BWXT is hosting a visit and tour for Wabigoon Lake Ojibwa Nation and Nuclear Waste Management Organization.
- BWXT employees will volunteer at Oasis Dufferin's food bank.

Augustin asked if CLC members had any feedback, suggestions for topics, or information from the community. CLC member Santano shared there is excitement surrounding the new apartment complex at 980 Lansdowne Avenue. CLC member Sepczynska added there is more public trust and felt that the increase in property value in the neighbourhood surrounding our facility is evidence. CLC member Santano suggested BWXT should focus on informing the public of the positives of nuclear energy, the benefits of life-saving nuclear medicine and shared it would be beneficial for the community to learn more about nuclear waste management and safety around stored fuel.

Augustin shared that she would send out year-end evaluation to CLC members and concluded the meeting.
